

**VILLAGE OF HARTVILLE
ORDINANCE NO. 1-17.09**

ORDINANCE NO. 1-17.09, enacting an Ordinance for the Village of Hartville ("Village") to establish parking restrictions for residential streets located within the Village of Hartville.

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF HARTVILLE,
STARK COUNTY, OHIO:**

Section 1. Findings and Determinations. The Village finds and determines the following matters:

- a) It is prudent to impose parking restrictions upon residential streets located within the Village so as to avoid any and all potential public hazards impairing normal transportation and/or movement of emergency vehicles to residents and/or occupants on said residential streets.
- b) Accordingly, the Council, acting in the best interest of the Village, hereby enacts Ordinance No. 1-17.09 as set forth in Section 2 below.
- c) All formal actions of this Council relating to the enactment of the Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law, including Section 121.22 of the Ohio Revised Code.

Section 2. RESIDENTIAL STREET PARKING RESTRICTIONS.

- a) The Village hereby states that no person shall park or cause to be parked or permit or suffer to remain parked any vehicle, whether operational or non-operational, upon any residential streets located within the Village except as permitted under subsection (c) or (d) of this section.
- b) Signage. Appropriate signage shall be posted.
- c) Permitted Residential Street Parking. Except as provided under subsection (d) of this section, non-commercial vehicle parking is permitted only on the following residential streets and as follows:
 - i. on the East side of Adelaide Avenue;
 - ii. on the N side of Byberry Drive;
 - iii. on the East side of Cloverlane Avenue;
 - iv. on the South side of Cornerstone Street;
 - v. on the W side of Erie Avenue;
 - vi. on the W side of Glenberry Avenue;
 - vii. on the NE side of Heatherby Drive;
 - viii. on the S side of Jefferson Street East & West
 - ix. on the E side of Lake Avenue;
 - x. on the NW side of Leighfield Lane;
 - xi. on the E side of Lisa Avenue;

- xii. on the N side of Meandering Creek;
- xiii. on the S side of Menlo Park; Grand Trunk to Crestmont (South) and Crestmont to Steffy (North)
- xiv. on the S side of Northampton Street;
- xv. on the S side of Washington Street East & West
- xvi. on the S side of Wauconda Trail;
- xvii. on the S side of Wisteria Avenue; and
- xviii. on the N side of Wyandotte Trail.

- d) **Unloading Exception.** Non-commercial vehicles may be parked on either side of the street, notwithstanding the preceding section, for a period not longer than ten (10) minutes for actual loading or unloading of passengers, or thirty (30) minutes for actual loading or unloading of property; provided, further, that no other ordinance or law restricting parking as to place or time is violated thereby.
- e) **Penalties.** Whoever violates any provision of this section is guilty of a minor misdemeanor on a first offense; on a second offense within one year after the first offense, the person is guilty of a misdemeanor of the fourth degree; on each subsequent offense within one year after the first offense, the person is guilty of a misdemeanor of the third degree.

Section 3. Repeal of Inconsistent Ordinances. All previous ordinances that are inconsistent with this Ordinance, are repealed as of the effective date of this Ordinance.

Section 4. Effective Date. This ordinance will take effect and be in full force at the earliest time allowed by law.
